Citations for failure to license and failure to provide rabies vaccination will be dismissed if corrected within 7 calendar days, including day of issuance

Citations for failure to spay or neuter a dog or a cat over 6 months, will be dismissed if an unaltered animal certificate is purchased or if the animal is spayed or neutered within 30 calendar days, including day of issuance.

All non-correctable penalties will be reduced by 50% if they are paid in full by close of business of the first business day following issuance.

To pay the fine or plead not guilty to the offenses you are cited for, please come in person to 2200 7th Avenue in Santa Cruz between the hours of 12:00 PM and 7:00 PM Tuesday through Friday or 12:00PM to 5:00 PM Saturday and Sunday. You can also come in person to 580 Airport Boulevard in Watsonville between 9:00 AM and 5:30 PM Monday through Saturday. Please be advised the Watsonville location is closed from 12:00 PM to 1:00 PM for lunch. You must file your appeal within 10 days from citation issuance.
